    - Just need a moderator
    - Set up through legal aid - new platform
      - Should all be squared away
- Print Materials
  - LHP Manual
    - Currently being translated into Spanish
    - English is good to go
    - Requests for people to look at related town hall
    - May be posted on AG's website
      - Reena wanted to run by PREC
    - Some discussion last time about hard copies to libraries
      - There is apparently some funding now but it is unclear how much that is
  - Fritz from AG put together doc explaining roles of all the task force committees
    - Descriptions of committees
    - Has been looked over
    - Might be making a resource page or under each committee subpage
    - Redundancy may be better than exclusivity for search purposes
      - No harm

- Only need to make sure things are consistently updated
    - Could just have link redundancy pointing to resource page
    - PDF's are indexed and searchable through Google
      - So no major concern about having PDF versions posted
    - Why not use the one-pager from a while ago
      - Some committees struck language to keep it to actually one page
      - Understanding that it was at some point supposed to be cleared by PREC
    - No harm in having liaisons taking it back to committees to look over
  - This and the one-pager could potentially be merged
- SANE Survey
  - 1800 new responses
  - Very limited Spanish language responses
  - Custody cases up, divorce down
  - Reported quality of remote hearings was diminished
  - Only 78% felt adult protective services was well functioning
  - Drop in reporting to both adult protective services and child protective services
  - There are some hard copies thanks to AG
    - Email Shelly if looking for hard copy
  - Have extended the deadline to 11/16
    - Can't go further to get a report
- PREC and Task Force
  - PREC
    - Single point of entry
      - Working with United Way and self-help centers to figure out how to move that conversation forward
      - In support - committees without resource manuals consider
    - What might some expected costs be for printed materials, etc.
  - Task Force
    - Last meeting will be next week
    - Looking to have final report by December
    - Official launch in beginning of January before beginning of leg session
  - How do we continue to coordinate with each other?
  - May be good to develop a document of people that are "champions" or certain subject areas
