INDICTMENT

The Grand Jurors for the State of Maryland for Baltimore County charge:

<u>COUNT ONE</u> (PARTICIPATION IN CRIMINAL GANG)

The Jurors of the State of Maryland for the body of Baltimore County, do on their oath present that, from at least April 2022 through the present day, in Baltimore County, Baltimore City, and elsewhere in Maryland, the DEFENDANT, along with Lovelle LITTLE, Kevin MILLS, Twan ELLIS, and others known and unknown to the Jurors, did knowingly, intentionally, and unlawfully combine, confederate, agree, and conspire to participate in, facilitate, aid, abet, assist, encourage, incite, approve of, protect, and promote an organization whose objective was to take the personal property of others, including cellular phones, other electronic devices, cash, motor vehicles, and other assorted personal property for financial gain, accomplishing this objective by unlawful criminal means including, but not limited to, commercial armed robberies, armed robberies, homicides, attempted murders armed carjackings, acts of violence, theft, and the illegal use of weapons including handguns, in violation of the Common Law of Maryland; against the peace, government, and dignity of the State.

Background, Manner, Means, and Methods of the Conspiracy

- 1. The Defendant, including Kevin MILLS, Twan ELLIS, and others known and unknown, are associates who have been working together as an organization to commit and carry out a spree of armed commercial robberies, armed robberies, armed carjackings, and thefts, in order to obtain control of the personal and business property of others for financial gain (hereinafter, "the Enterprise").
- 2. Members and associates of the Enterprise typically either take the personal property as their own, use the items to facilitate the commission of future robberies and thefts, and/or dispose of property that is unwanted or no longer needed.
- 3. Members and associates of the Enterprise typically take the business's property as their own for financial gain and dispose of the property that is unwanted or no longer needed.

- 4. The items that the Enterprise seeks control of include, but are not limited to, cellular phones and other electronic devices; ATM machines, cash registers, motor vehicles; wallets, credit cards, bank cards, and money; and other items that the members of the Enterprise want to keep as their own or believe will make them money.
- 5. Members and associates of the Enterprise frequently target victims who have just parked, have just exited their vehicle, and/or are walking to or from their homes and cars. Members and associates of the Enterprise will then, while the victim is standing in close proximity or walking away from their vehicle, attack the victim, steal the victim's property, and flee in the victim's car and/or in a getaway vehicle (which is often a previously stolen vehicle).
- 6. While committing these crimes, members and associates of the Enterprise dress in clothing that conceals their identities from victims, witnesses, and surveillance. For example, members of the Enterprise will wear masks covering their faces as well as dark clothing. Members and associates of the Enterprise frequently carry out their crimes at nighttime.
- 7. Members and associates of the Enterprise utilize handguns and bricks in order to commit robberies, carjackings, and auto thefts. Members and associates of the Enterprise frequently point the handguns at the victims, threatening them to relinquish control of their personal property. Members of the Enterprise also frequently use bricks to break into and gain access to commercial businesses.
- 8. Members and associates of the Enterprise regularly commit violence to accomplish their objectives, often continuing to assault the victim after the members and associates have control of the victim's vehicle and personal property.
- 9. In a typical robbery committed by the Enterprise, members and associates have different roles, including but not limited to the following: bringing handguns and other weapons to threaten and assault the victims; waiting nearby as lookouts or getaway drivers; taking and resuming control over the stolen property; disposing of property that is unwanted or no longer needed; and engaging in other acts that further the success of the serial robberies committed by the Enterprise.
- 10. In a typical robbery committed by the Enterprise, members and associates quickly approach their victim in an organized fashion, and immediately, while brandishing weapons—often pointed at the victim's head—demand that the victim turn over all of his/her personal property.
- 11. In a typical commercial robbery committed by the Enterprise, members and associates use bricks to break into businesses to gain access to ATM machines and cash registers which they often take out of the businesses and later open to retrieve cash. Members and associates of the Enterprise also steal other products within the businesses.
- 12. Members and associates of the Enterprise sometimes order the victim—while holding them at gunpoint—to unlock their cellular phone and disable any location tracking applications or settings. Members and associates of the Enterprise will, when possible, take control

of the user account associated with the cellular phone, in an attempt to prevent the victim or law enforcement from accessing or tracking the phone remotely.

- 13. Members and associates of the Enterprise would take photographs and gather pertinent information about the stolen vehicles including but not limited to license plate numbers, vehicle identification numbers, and vehicle title information, send the information and photographs to another associate who would then direct members of the Enterprise where to take the stolen vehicles.
- 14. Members and associates of the Enterprise utilize Facebook Marketplace to sell and dispose of the stolen property.
- 15. Members and associates of the Enterprise not only interact with each other and many of the same individuals in and around Maryland, but also are connected with each other and many of the same individuals on social media, particularly Facebook and Instagram, which they use to communicate with each other during the course of this conspiracy.
- 16. Members and associates of the Enterprise have been known to document themselves "posing" with the cash, stolen property, and firearms by posting photos on their social media accounts.
- 17. Members and associates of the Enterprise are known to reside at, frequent, and store stolen property in/at and/or near, the following locations in Baltimore City, Maryland: the 2400 block of Baker Street, 2200 block of Presstman Street, 1500 block of North Pulaski Street, 1500 block of North Bentalou Street, 2800 block of Rockrose Avenue, 4100 block Towanda Avenue, 2800 block of Violet Avenue which are "hubs" for the Enterprise's operations. Several stolen vehicles have also been stored in front of, across the street from, around the block from, or in close vicinity to the locations.

Overt Acts in Furtherance of the Conspiracy

- 18. In furtherance of the conspiracy and to achieve the objectives thereof, members and associates of the Enterprise, including the Defendant and others known and unknown, performed and caused to be performed the following acts, among others, in Maryland, including in Baltimore County, Baltimore City, and elsewhere:
- 19. On April 24, 2022, in or near the 1500 block of North Bentalou Street, Baltimore, Maryland, the Enterprise carjacked (Victim 1) at gunpoint. While Victim 1 was sitting at red light, the Enterprise blocked Victim 1's vehicle in, exited their vehicle and pointed a handgun at Victim 1 demanding that Victim 1 exit the vehicle. The Enterprise stole Victim 1's 2015 Beige Nissan Sentra. Victim 1's vehicle was recovered on December 31, 2022 in the 2200 block of Presstman Street.
- 20. On April 27, 2022, at or near 1769 Washington Boulevard, Baltimore, Maryland, the Enterprise carjacked (Victim 2) at gunpoint. Victim 2 pulled into a parking

space at the location, and the Enterprise exited their vehicle, pointed a handgun at Victim 2 and forced Victim 2 out of the vehicle. The Enterprise stole Victim 2's 2009 gray Nissan Rogue.

- 21. On April 27, 22, in or near the 2200 block of Calloway Avenue, Baltimore, Maryland, the Enterprise carjacked (Victim 3) at gunpoint. Victim 3 was in the block picking up a friend when the Enterprise pulled alongside of him, exited their vehicle and forced him out of the vehicle at gunpoint. The Enterprise stole Victim 3's white 2009 Nissan Altima. Victim 3's white 2009 Nissan Altima was recovered on December 31, 2022 in the 2200 block of Presstman Street.
- 22. On April 27, 2022, in or near the 2600 block of Huntingdon Avenue, Baltimore, Maryland, the Enterprise carjacked (Victim 4) at gunpoint. Victim 4 was walking to his vehicle when the Enterprise blocked his walking path with their vehicle, exited their vehicle and demanded the keys to Victim 4's vehicle. The Enterprise stole Victim 4's 2017 gray Honda Accord. Victim 4's ID and credit cards were found in the residence of Lovell LITTLE, a member of the Enterprise.
- 23. On May 11, 2022, at or near 135 Monastery Avenue, Baltimore, Maryland, the Enterprise stole an Amazon delivery driver's vehicle (Victim 5). As Victim 5 was delivering an Amazon package, the Enterprise entered Victim 5's vehicle and drove away, stealing Victim 5's 2007 black Chrysler 300. Victim 5's 2007 black Chrysler 300 was recovered on June 15, 2022 in the 2300 block of Baker Street.
- 24. On June 5, 2022, at or near 5230 Moravia Road, Baltimore, Maryland, the Enterprise broke into the Hip Hop Fish & Chicken restaurant. Using bricks to break the glass doors, the Enterprise entered the location and stole two cash registers.
- 25. On June 15, 2022, in or near the 1500 block of Northbourne Road, Baltimore, Maryland, the Enterprise attempted to carjack scale (Victim 6) vehicle. The Enterprise exited their vehicle and demanded that Victim 6 hand over their car key. As the Enterprise attempted to open Victim 6's car door, Victim 6 drove off, crashing into the suspect vehicle.
- 26. On June 15, 2022, in or near the 1600 block of Northgate Road, Baltimore, Maryland, the Enterprise carjacked solution 's (Victim 7) vehicle. As Victim 7 sat in their vehicle, the Enterprise parked and exited their vehicle and forced Victim 7 out of their vehicle. The Enterprise stole Victim 7's burgundy 2019 Toyota Highlander. Victim 7's burgundy 2019 Toyota Highlander was recovered on June 15, 2022 in the 2400 block of Baker Street.
- 27. On September 11, 2022, at or near 2835 Hampden Avenue, Baltimore, Maryland, the Enterprise carjacked (Victim 8) at gunpoint. While Victim 8 approached their vehicle with their keys in hand, the Enterprise approached Victim 8 with handguns and took his keys. The Enterprise stole Victim 8's silver 2013 Chevrolet Equinox. Victim 8's silver 2013 Chevrolet Equinox was recovered on September 19, 2022 in the 1500 block of Pulaski Street.
- 28. On September 11, 2022, in or near the 1100 block of Red Road, Baltimore, Maryland, the Enterprise carjacked and robbed (Victim 9) at gunpoint. As Victim 9 was

driving his vehicle, the Enterprise cut him off with their vehicle, blocking Victim 9's path, exited their vehicle, and approached Victim 9 with handguns and demanded that Victim 9 "get the fuck out of the car." The Enterprise stole Victim 9's 2018 silver Chevrolet Malibu and his wallet. Victim 9's vehicle was recovered on September 14, 2022 in the 1500 block of Pulaski Street.

- 29. On September 24, 2022, in or near the 1500 block of North Smallwood Street, Baltimore, Maryland, the Enterprise discharged a firearm. One 9mm shell casing was recovered.
- 30. On October 23, 2022, at or near 5212 Loch Raven Boulevard, Baltimore, Maryland, the Enterprise stole 's (Victim 10) white 2015 Kia Forte.
- 31. On October 28, 2022, in or near the 3600 block of Reisterstown Road, Baltimore, Maryland, the Enterprise stole (Victim 11) silver 2016 Hyundai Sonata. Victim 11's silver 2016 Hyundai Sonata was recovered on December 16, 2022 in the 3500 block of Greenmount Avenue after it had been involved in an accident.
- 32. On October 29, 2022, at or near 5600 Reisterstown Road, Baltimore, Maryland, the Enterprise, using Victim 10's white 2015 Kia Forte, attempted carjack significantly is (Victim 12) at gunpoint. While Victim 12 was paying for his gasoline, the Enterprise entered Victim 12's dark colored BMW and attempted to steal the vehicle. As Victim 12 and the Enterprise struggled over the vehicle, another member of the Enterprise began to fire a handgun at Victim 12. The four shell casings recovered from the location were consistent with the shell casings recovered on September 24, 2022 from the 1500 block of North Smallwood Street.
- 33. On October 29, 2022, at or near 4704 Loch Raven Boulevard, Baltimore, Maryland, the Enterprise stole (Victim 13) black 2017 Kia Sportage.
- 34. On November 1, 2022, in or near the 3300 block of Woodbrooke Avenue, Baltimore, Maryland, the Enterprise, utilizing Victim 12's vehicle, carjacked (Victim 14) at gunpoint. While Victim 14 sat in their vehicle, the Enterprise approached the vehicle and demanded that Victim 14 exit the vehicle. The Enterprise stole Victim 14's silver 2016 Honda Civic. Victim 13's black 2017 Kia Sportage was recovered at the scene.
- 35. On November 2, 2022, in or near the 1200 block of Ashburton Street, Baltimore, Maryland, the Enterprise discharged a firearm. Victim 24 Baltimore, Maryland, the Enterprise carjacked was sitting in his white 2018 Hyundai Tucson when the Enterprise approached his vehicle and stated, "get the fuck out of the car." The Enterprise then pistol-whipped Victim 24 and stole his white 2018 Hyundai Tucson and his green Apple iPhone 13. Victim 24's White Hyundai Tucson was recovered on December 31, 2022 in the 1500 block Bentalou Street. Victim 24's Apple iPhone was pawned Lovelle LITTLE, a member of the Enterprise. 43. On December 10, 2022, in or near the 1700 block of Moreland Avenue, Baltimore, (Victim 25) at gunpoint. While Victim Maryland, the Enterprise carjacked 25 sat in his gray 2012 Honda Accord, the Enterprise, using Victim 24's white 2018 Hyundai Tucson, pulled up next to Victim 25, exited the vehicle and stated, "you know what it is." The Enterprise then stole Victim 25's gray 2012 Honda Accord. Victim 25's gray 2012 Honda Accord was recovered on December 13, 2022 in the 2200 block of Baker Street.

One of the 9mm shell casings recovered was consistent with the 9mm shell casings recovered on November 3, 2022 in the 2500 block of Brookfield Avenue where Victim 18 was killed, consistent with the 9mm shell casing located on September 24, 2022 in the 1500 block of North Smallwood Street, consistent with the 9mm shell casings located on October 29, 2022 in the 5600 block of Reisterstown Road, consistent with the 9mm shell casings located on November 2, 2022 in the 1200 block of Ashburton Street.
- 45. On December 16, 2022, at or near 1514 Caton Avenue, Baltimore, Maryland, the Enterprise carjacked (Victim 26) at gunpoint using Victim 11's silver 2016 Hyundai Sonata. While Victim 26 was pumping gas into her gray 2014 Dodge Charger, the Enterprise exited a vehicle with handguns and demanded Victim 26's keys. The Enterprise stole Victim 30's silver 2019 Chevrolet Traverse and his Apple iPhone 13. Victim 30's silver 2019 Chevrolet Traverse was recovered on December 18, 2022 in the 1300 block of Harlem Avenue.

- 56. On December 25, 2022, in or near the 1900 block of Letitia Avenue Baltimore, Maryland, the Enterprise carjacked (Victim 39) at gunpoint. While Victim 39 sat in his green 2013 Toyota Sienna, the Enterprise, using a white SUV, backed into his vehicle and

approached Victim 39 displaying several handguns and demanded that he "give up his property" and "exit the vehicle." After refusing to unlock and "give up" his Apple iPhone 11, the Enterprise pistol-whipped Victim 39. The Enterprise stole Victim 39's green 2013 Toyota Sienna. The Enterprise stole Victim 65's brown 2016 Infinity Q70, an Apple iPhone 12 Pro, and keys to another vehicle.
- 86. On January 14, 2023, in or near the 1100 block of Cleveland Street, Baltimore, Maryland, the Enterprise, using Victim 65's brown 2016 Infinity Q70, discharged several firearms. Six 9mm shell casings were recovered from the scene and were consistent with the 9mm shell casings recovered from the 1500 block of North Smallwood Street on September 24, 2022, the 9mm shell casings recovered from the 5600 block of Reisterstown Road on October 29, 2022, the 9mm shell casings recovered from the 1200 block of Ashburton on November 2, 2022, the 9mm shell casings recovered from the 3200 block of Rosalie Road on December 10, 2022, and the 9mm shell casings recovered from the 1400 block of Monroe Street on December 13, 2022. Two .40 caliber shell casings were also recovered. The firearm used in this incident was recovered from residence of Anecio Rodriguez, a member of the Enterprise.

While Victim 66 was inspecting his work truck, the Enterprise approached him displaying several handguns and stated, "give me everything before I blow your head off." The Enterprise then went through Victim 66's pockets and stole his wallet, his cell phone, and the key fob to his gray 2015 Mercedes Benz C300. The Enterprise then fled the area in Victim 66's gray 2015 Mercedes Benz C300. Victim 66's gray 2015 Mercedes Benz C300 was recovered on January 14, 2023 in the 1200 block of Linworth Avenue.
- 88. On January 14, 2023, at or near 1247 Linworth Avenue, Baltimore, Maryland, the Enterprise stole stole (Victim 67) black 2011 Infiniti M37. Victim 67's black 2011 Infiniti M37 was recovered on January 14, 2023 in the 1200 block of Linworth Avenue near Victim 66's gray 2015 Mercedes Benz C300.
- 89. On January 14, 2023, at or near 206 West Coldspring Lane, Baltimore, Maryland, the Enterprise, using Victim 65's brown 2016 Infinity Q70, stole statement of Statement (Victim 68) white 2017 Mercedes Benz GLC 300. Victim 68's white 2017 Mercedes Benz GLC 300 was recovered on January 14, 2023 in the 2900 block of Belmont Avenue.
- 90. On January 14, 2023, at or near 2500 Liberty Heights Avenue, Baltimore, Maryland, the Enterprise, using Victim 65's brown 2016 Infinity Q70, carjacked (Victim 69) at gunpoint. While Victim 69 was leaving the 7/11 convenience store, the Enterprise approached him with several handguns and demanded his vehicle and money. The Enterprise fled in Victim 69's blue 2016 Infiniti QX50. The Enterprise also stole Victim 69's Smith & Wesson

.380 handgun. Victim 69's blue 2016 Infiniti QX50 was recovered on January 16, 2023 in the 3300 block of West Baltimore Street.

- 91. On January 23, 2023, in or near the 1500 block of Medford Road, Baltimore, Maryland, the Enterprise stole Victim 63's black 2013 Jaguar XF (See paragraph 83). Victim 63's black 2013 Jaguar XF was recovered on February 2, 2023 in the 5300 block of Kenilworth Avenue. 92. On January 23, 2023, at or near 102 North Clinton Street, Baltimore, Maryland, the Enterprise, using Victim 63's black 2013 Jaguar XF, the Enterprise robbed (Victim 720, and (Victim 71), (Victim 73) at gunpoint. While Victim 70 was closing up her business for the day, the Enterprise approached the victims displaying several handguns and demanded money and property. On January 30, 2023, in or near the 5900 block of Saint Regis Road, Baltimore, Maryland, the Enterprise, using Victim 74's light blue 2016 Hyundai Sonata, broke into several vehicles and stole property. The Enterprise broke into s (Victim 75) brown 2008 (Victim 76) black 2016 Cadillac XTS; 's black s (Victim 77) silver 2007 Chevrolet Impala and black 2016 Chevrolet Impala; 's red 1997 Ford F-150. The Enterprise stole Victim 78's 2019 Nissan Murano; and purse containing her wallet and Victim 79's wallet containing \$150 in U.S. currency. 95. On January 30, 2023, at or near 5246 Harford Road, Baltimore, Maryland, the Enterprise, using Victim 74's light blue 2016 Hyundai Sonata, broke into the Papa John's Pizzeria. The Enterprise gained access to the pizzeria by using brick to break the glass door. 96. On January 30, 2023, at or near 5232 Harford Road, Baltimore, Maryland, the Enterprise, using Victim 74's light blue 2016 Hyundai Sonata, broke into the Royal Farms convenience store. The Enterprise gained access to the store by using brick to break the glass doors. 97. On January 30, 2023, in or near the 300 block of Grundy Street, Baltimore, Maryland, the Enterprise, using Victim 74's light blue 2016 Hyundai Sonata, attempted to carjack (Victim 80) at gunpoint. While Victim 80 was sitting in his red 2014 Toyota Corolla, the Enterprise blocked Victim 80's vehicle and approached him displaying several handguns and demanded the keys to the vehicle. Victim 80 was able to drive away from the scene.
- 98. On January 30, 2023, at or near 405 Gusryan Street, Baltimore, Maryland, the Enterprise, carjacked (Victim 81) at gunpoint. While Victim 81 was exiting his red 2018 Toyota Corolla, the Enterprise approached him displaying a knife and held it to Victim 81's neck and demanded the vehicle. The Enterprise stole Victim 81's red 2018 Toyota Corolla, an

Apple iPhone 11, and \$800 in U.S. currency. Victim 81's red 2018 Toyota Corolla was recovered on February 1, 2023 in the 5100 block of Northwood Drive.

- Maryland, the Enterprise, carjacked (Victim 82) at gunpoint. While Victim 82 was walking away from his blue 2006 Acura TL, the Enterprise approached him displaying several handguns and demanded the keys to his vehicle. When Victim 82 refused, the Enterprise ran into him with a vehicle, pointed the handgun at him, took his car keys, and fled the scene in blue 2006 Acura TL. Victim 82's blue 2006 Acura TL was recovered on January 30, 2023 in the 2900 block of Rockrose Avenue.
- 100. On January 30, 2023, Victim 74's light blue 2016 Hyundai Sonata was recovered in the 3800 block of East Pratt Street.
- 101. On February 8, 2023, at 1636 Ruxton Avenue, Baltimore, Maryland, Lovelle Little possesses two firearms: a Titan Tiger .380 revolver and a Taurus G3 9mm handgun. The Taurus 9mm handgun was stolen from Victim 15 on November 2, 2022. (See paragraph 36)
- 102. On March 9, 2023, at 1319 Crofton Road, Baltimore, Maryland, Anecio Rodriguez possessed a .40 caliber handgun. This firearm is consistent with the firearm used on January 14, 2023 in the 1100 block of Cleveland Street. (See paragraph 86)
- 103. On August 2, 2023, at or near 900 West Patapsco Avenue, Baltimore, Maryland, the Enterprise carjacked (Victim 83) at gunpoint. While Victim 83 was washing his silver 2011 Honda Accord, the Enterprise approached him displaying several handguns and demanded his car keys. The Enterprise fled the scene is Victim 83's silver 2011 Honda Accord. Victim 83's silver 2011 Honda Accord was recovered on September 19, 2023 in the 1300 block of Crofton Road next to the residence of Anecio Rodriguez, a member of the Enterprise

TO THE PERSON CHARGED:

- 1. This paper charges you with committing a crime.
- 2. If you have been arrested and remain in custody, you have the right to have a judicial officer decide whether you should be released from jail until your trial.
- 3. If you have been served with a citation or summons directing you to appear before a judicial officer for a preliminary inquiry at a date and time designated or within five days of service if no time is designated, a judicial officer will advise you of your rights, the charges against you, and penalties. The preliminary inquiry will be cancelled if a lawyer has entered an appearance to represent you.
- 4. You have the right to have a lawyer.
- 5. A lawyer can be helpful to you by:
 - (A) explaining the charges in this paper;
 - (B) telling you the possible penalties;
 - (C) explaining any potential collateral consequences of a conviction, including immigration consequences;
 - (D) helping you at trial;
 - (E) helping you protect your constitutional rights; and
 - (F) helping you get a fair penalty if convicted.
- 6. Even if you plan to plead guilty, a lawyer can be helpful.
- 7. If you are eligible, the Public Defender or a court-appointed attorney will represent you at any initial appearance before a judicial officer and at any proceeding under Rule 4-216.1 to review an order of a District Court commissioner regarding pretrial release. If you want a lawyer for any further proceeding, including trial, but do have the money to hire one, the Public Defender may provide a lawyer for you. The court clerk will tell you how to contact the Public Defender.
- 8. If you want a lawyer but you cannot get one and the Public Defender will not provide one for you, contact the court clerk as soon as possible.
- 9. DO NOT WAIT UNTIL THE DATE OF YOUR TRIAL TO GET A LAWYER. If you do not have a lawyer before the trial date, you may have to go to trial without one.
