INDICTMENT

The Grand Jurors for the State of Maryland for Anne Arundel County charge:

<u>COUNT ONE</u> (PARTICIPATION IN A CRIMINAL ORGANIZATION)

The Jurors of the State of Maryland for the body of Anne Arundel County, do on their oath present that, aforesaid DEFENDANT, at least as early as February 2021 through the present day, in Anne Arundel County, Baltimore City, and Baltimore County, of the State of Maryland, along with others known and unknown to the Jurors, did participate in a criminal organization, referred to herein as the "Enterprise," knowing that the members of said organization engage in organized criminal activity and knowingly and willfully directed and participated in an underlying crime committed for the benefit of, at the direction of, and in association with a criminal organization, in violation of the Criminal Law Article, Section 9-804(a), of the Maryland Code; against the peace, government, and dignity of the State.

Background

- 1. Since at least February 2021, the Defendants and others known and unknown, have been members and associates of a criminal enterprise that was operating in Anne Arundel County, and elsewhere (hereinafter "the Enterprise").
- 2. The members of the Enterprise consist of, among others, individuals who have a biological relationship to other members, a historical friendship with other members, or a longstanding business relationship with respect to drug sales.
- 3. The Enterprise consists of individuals who are high-ranking members, who direct, manage, and supervise the lower-ranking members with respect to drug distribution. Dwayne Booze is a high-ranking member who maintains control of the Enterprise's drug supply. The Enterprise contains individuals who process and manufacture controlled dangerous substances CDS on behalf of the Enterprise.

Manner, Means, and Methods of the Conspiracy

- 4. The Enterprise seeks, among other things, to maintain control of the drug trade in its territory, to expand its drug trade into new territory, and to protect the members and operations of the Enterprise from interdiction and interruption by law enforcement. The manner, means, and methods by which the Defendants and their associates achieve the objectives of the conspiracy include, but are not limited to, the following:
- 5. Members and associates of the Enterprise do, individually and collectively, distribute and conspire to distribute, among other things, cocaine, cocaine base, fentanyl, heroin, and marijuana, on behalf of the Enterprise in the territory controlled by the Enterprise.
- 6. Members and associates of the Enterprise do, individually and collectively, manufacture, process, and prepare controlled dangerous substances ("CDS") on behalf of the Enterprise.
- 7. Members and associates of the Enterprise do own and operate seemingly legitimate businesses in an attempt to further and facilitate its drug trade, including using the businesses as a location to store and distribute CDS, disguise the purchase and sale of CDS, and to legitimize the transfer of U.S. currency.
- 8. Members and associates of the Enterprise do, individually and collectively, wear, carry, and transport, and conspire to wear, carry, and transport firearms. Members and associates of the Enterprise do, individually and collectively, possess and use firearms during, and in relation to, the trafficking of CDS.
- 9. Members and associates of the Enterprise use counter-surveillance techniques and work together, collectively, to avoid detection by law enforcement.
- 10. Members and associates of the Enterprise use cellular telephones and social media accounts to communicate with one another concerning and during the commission of the Enterprise's illegal activities, including to plan meetings to exchange money or CDS, check on the status of the CDS distribution locations, communicate with customers and suppliers of CDS, and warn each other about law enforcement presence.
- 11. Members and associates of the Enterprise use multiple cellular telephones, numbers, and devices during the commission of the Enterprise's illegal activities in an attempt to avoid detection and apprehension by law enforcement. Members and associates of the Enterprise, at the direction of higher-ranking members, replace their cellular devices and telephone numbers in an attempt to avoid detection and apprehension by law enforcement.
- 12. Members and associates of the Enterprise often communicate through coded language and short text messages in an attempt to conceal the illegal acts done in furtherance of the Enterprise, and to avoid detection and apprehension by law enforcement.

- 13. Members and associates of the Enterprise utilize their businesses and the homes of members, associates, and family members, to stash, store, process, and safeguard illegal CDS, weapons, and proceeds, and as a place to retreat to in the event of law enforcement activity in the area.
- 14. Members and associates of the Enterprise utilize vehicles to distribute CDS to customers at their businesses, homes, at the homes of family members, at the stash location, or at other businesses including restaurants and retail establishments throughout Anne Arundel County, Baltimore County, Howard County, and Baltimore City. Often, CDS transactions are conducted in the open, or within and between their vehicles or the vehicles of their customers.
- 15. Members and associates of the Enterprise will use third-parties or other members and associates of the Enterprise to transport and distribute CDS on their behalf in order to avoid detection by law enforcement.
- 16. Members and associates of the Enterprise utilize interstate parcel carriers to facilitate the purchase and distribution of CDS on behalf of the Enterprise.

Overt Acts in Furtherance of the Conspiracy

- 17. From at least February 2021 through the present day, members and associates of the Enterprise utilized social media, including Facebook, and cellular phones to communicate about controlled dangerous substances, money, meeting locations, and to otherwise facilitate the distribution of controlled dangerous substances. Often those conversations were coded to avoid law enforcement and conceal the illicit nature of the conversations.
- 18. On March 18, 2021, Dwayne Booze, Maurice Dotson, and an unknown individual exchanged CDS and/or U.S. Currency at Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland.
- 19. On March 31, 2021, Dwayne Booze and Maurice Dotson exchanged CDS and/or U.S. currency at Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland.
- 20. On June 17, 2021, Dwayne Booze, Michael Booze, and Maurice Dotson exchanged CDS and/or U.S. currency at Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland.
- 21. On June 23, 2021, plastic bags and other drug wrappers containing cocaine residue were recovered from the trash at 1214 W. Cross Street in Baltimore City, Maryland.
- 22. On June 24, 2021, Dwayne Booze and an unknown individual exchanged CDS and/or U.S. currency at Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland.

- 23. On July 7, 2021, Michael Booze transported CDS and/or U.S. currency from 1214 W. Cross Street in Baltimore City, Maryland to Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland. Dwayne Booze and Thomas William Booze were also present at the location on that date.
- 24. On July 16, 2021, Dwayne Booze and Rapheela Finnegan transported CDS and/or U.S. currency between 1611 E. Fairmont Avenue, 1214 W. Cross Street, and 1240 W. Pratt Street, all located in Baltimore City, Maryland. During this time, Michael Booze was present at 1214 W. Cross Street, Baltimore City, Maryland.
- 25. On July 20, 2021, Dwayne Booze transported CDS and/or U.S. currency from 1214 W. Cross Street, Baltimore City, Maryland, to Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland. Michael Booze was present at 1214 W. Cross Street. Thomas Timothy Booze was present at 1240 W. Pratt Street.
- 26. On July 31, 2021, Dwayne Booze and an unknown individual exchanged CDS and/or U.S. currency at 1214 W. Cross Street, Baltimore City, Maryland.
- 27. On August 4, 2021, Michael Booze transported CDS and/or U.S. currency from 1214 W. Cross Street to at Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland. Dwayne Booze and Michael Booze exchanged CDS and/or U.S. currency at or near 1240 W. Pratt Street, Baltimore City, Maryland.
- 28. On August 26, 2021, Thomas Timothy Booze transported CDS and/or U.S. currency between 1214 W. Cross Street and Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland. Thomas Timothy Booze and Michael Booze exchanged CDS and/or U.S. currency at 1214 W. Cross Street, Baltimore City, Maryland.
- 29. On September 16, 2021, Michael Booze distributed CDS to Thomas Timothy Booze at or near 1214 W. Cross Street, Baltimore City, Maryland.
- 30. On September 17, 2021, Dwayne Booze directed Michael Booze to exchange CDS and/or U.S. currency with another member of the Enterprise at or near 1214 W. Cross Street, Baltimore City, Maryland.
- 31. On September 18, 2021, Michael Booze distributed CDS to Dwayne Booze at or near 1214 W. Cross Street, Baltimore City, Maryland.
- 32. On September 19, 2021, at the direction of Dwayne Booze, Michael Booze distributed CDS to Dominic Mooney at or near Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland.
- 33. On September 20, 2021, Michael Booze distributed CDS to Dwayne Booze at or near 1214 W. Cross Street, Baltimore City, Maryland.

- 34. On September 20, 2021, at the direction of Dwayne Booze, Michael Booze distributed CDS to Thomas Timothy Booze at or near 1214 W. Cross Street, Baltimore City, Maryland. Thomas Timothy Booze transported the CDS to Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland.
- 35. On September 20, 2021, Dwayne Booze and Rapheela Finnegan distributed CDS to Leon Holman at or near 3819 North Point Blvd., Dundalk, Baltimore County, Maryland.
- 36. On September 21, 2021, Dwayne Booze distributed CDS to Dominic Mooney at or near Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland.
- 37. On September 21, 2021, Thomas William Booze provided U.S. currency to the Enterprise, at the direction of Dwayne Booze, for the purposes of funding CDS purchases for resale by the Enterprise at or near Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland.
- 38. On September 23, 2021, Michael Booze, at the direction of Dwayne Booze, distributed CDS to Thomas Timothy Booze at or near 1214 W. Cross Street, Baltimore City, Maryland.
- 39. On September 23, 2021, Michael Booze distributed CDS to Dwayne Booze at or near Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland.

Michael Booze distributed CDS to Thomas William Booze at 7624 Furnace Branch Road, Glen Burnie, Anne Arundel County, Maryland.
- 70. On or about November 18, 2021, Dwayne Booze coordinated the importation of CDS from out of state to 1214 W. Cross Street, Baltimore City, Maryland. Dwayne Booze communicated with Michael Booze, Thomas Timothy Booze, Maurice Dotson, and other unknown individuals to facilitate the importation of the CDS. An unknown male transported the CDS between 1214 W. Cross Street, Baltimore City, Maryland and Xclusive Services, located at 1240 W. Pratt Street, Baltimore City, Maryland.
- 71. On November 20, 2021, Michael Booze distributed CDS to Ashley Raley at or near 162 W. Meadow Lane, Baltimore, Anne Arundel County, Maryland.
- 72. On November 21, 2021, Thomas William Booze distributed CDS to Timothy Bryant at or near 66 Mountain Road, Glen Burnie, Anne Arundel County, Maryland.

- 73. On November 22, 2021, Michael Booze distributed CDS to Ashley Raley at or near 162 W. Meadow Lane, Baltimore, Anne Arundel County, Maryland.

Additionally, the Enterprise was found to be in possession of a Smith & Wesson 9 mm handgun, a revolver, and ammunition.
- 78. On or about December 7, 2021, a search and seizure warrant was executed at 1214 W. Cross Street, Baltimore, Maryland, a location controlled by the Enterprise and used as a stash location. The Enterprise was found to be in possession of numerous materials and substances used in the manufacturing, packaging, and distribution of CDS.
- 79. On or about December 7, 2021, a search and seizure warrant was executed at 6420 Union Court, Glen Burnie, Anne Arundel County, Maryland, a location utilized by Michael Booze as a residence. Michael Booze was found to be in possession of a digital scale, a Taurus handgun, and U.S. currency. An additional search and seizure warrant was executed at 162 W. Meadow Road, Brooklyn, Anne Arundel County, Maryland, another location used by Michael Booze as a residence. Additional U.S. currency was located, as well as marijuana and a handgun.
- 80. On or about December 7, 2021, a search and seizure warrant was executed at 1611 E. Fairmont Street, Baltimore City, Maryland, the residence of Dwayne Booze and Rapheela Finnegan. Dwayne Booze was found to be in possession of U.S. currency.
- 81. On or about December 7, 2021, a search and seizure warrant was executed at 3615 Spaulding Avenue, Baltimore, Maryland, the residence of Thomas Timothy Booze. Thomas Timothy Booze was found to be in possession of marijuana, ammunition, U.S. currency, and a digital scale.
- 82. On or about December 7, 2021, a search and seizure warrant was executed at 7905 Canter Court, Severn, Anne Arundel County, Maryland, the residence of Maurice Dotson. Maurice Dotson was found to be in possession of heroin, fentanyl, tramadol, U.S. currency, CDS packaging, and a money counter.

- 83. On or about December 7, 2021, a search and seizure warrant was executed at 5 Marley Neck Road, Glen Burnie, Anne Arundel County, Maryland, a location used by Thomas William Booze as a residence. Thomas William Booze was found to be in possession of U.S. currency and ammunition.

TO THE PERSON CHARGED:

- 1. This paper charges you with committing a crime.
- 2. If you have been arrested and remain in custody, you have the right to have a judicial officer decide whether you should be released from jail until your trial.
- 3. If you have been served with a citation or summons directing you to appear before a judicial officer for a preliminary inquiry at a date and time designated or within five days of service if no time is designated, a judicial officer will advise you of your rights, the charges against you, and penalties. The preliminary inquiry will be cancelled if a lawyer has entered an appearance to represent you.
- 4. You have the right to have a lawyer.
- 5. A lawyer can be helpful to you by:
- (A) explaining the charges in this paper;
- (B) telling you the possible penalties;
- (C) explaining any potential collateral consequences of a conviction, including immigration consequences;
- (D) helping you at trial;
- (E) helping you protect your constitutional rights; and
- (F) helping you get a fair penalty if convicted.
- 6. Even if you plan to plead guilty, a lawyer can be helpful.
- 7. If you are eligible, the Public Defender or a court-appointed attorney will represent you at any initial appearance before a judicial officer and at any proceeding under Rule 4-216.1 to review an order of a District Court commissioner regarding pretrial release. If you want a lawyer for any further proceeding, including trial, but do have the money to hire one, the Public Defender may provide a lawyer for you. The court clerk will tell you how to contact the Public Defender.
- 8. If you want a lawyer but you cannot get one and the Public Defender will not provide one for you, contact the court clerk as soon as possible.
- 9. **DO NOT WAIT UNTIL THE DATE OF YOUR TRIAL TO GET A LAWYER.** If you do not have a lawyer before the trial date, you may have to go to trial without one.
