- Language barriers
  - Closed captioning
  - If sign language interpreters are connected it would be valuable, if not then it is something to consider moving forward
    - Libraries used fee based service
      - Can look into turnaround time
    - Can reach out to legal aid's language access task force
- Check to make sure there are local numbers
- Questions, comments, suggestions
  - What is going to be our access portal bolster resources, 211, etc.
    - During financial crisis they created a hope hotline
      - One place where anyone dealing with foreclosure could go
      - Had housing and financial counselors along with legal help
      - Would start to receive help immediately very easy to get help they need
    - Made public awareness easier as well go to this one place
    - States with regular natural disasters have disaster legal services protocol
      - Must be activated then they set up a separate hotline
    - Self-help center created relationship with mediation service
    - This is coming from different committees
      - They have discussed committee specific points of entry legislators favor
    - Where do we want to funnel people through?
    - Possibility of making one central hub in long term and utilize separate systems for immediate use?
      - Previously mentioned one stop would take a long time to build
    - Where would printed materials for example be sending people?
      - Cannot just put out information with no point of contact
    - May not be able to use an existing service to create a far-reaching emergency network that has broad legal advice/services
      - But they could be given bare minimum and genuinely helpful information that could allow them to find the next point of contact
        - What to do, where to go from there, etc.
